



## Brief Introduction of Business Company in BRITISH VIRGIN ISLANDS 英屬處女群島商業公司概述

### About British Virgin Islands (BVI)

BVI total land area is around 150 sq. km. It is located 60 km. east of Puerto Rico, and northwest of Antigua in the Caribbean. It consists of 60 islands, with Tortola as the largest island.

BVI is a self-governed British Crown Colony, and a premier offshore commercial activities center.

BVI enjoys political and economic stability.

### Incorporation Methods of Business Company in BVI

#### 1. Purchasing ready-made Business Company

These companies will first be registered by us. The company is authorised to issue 50,000 shares, which can be in any currency. A list of ready-made Business Companies will be provided upon request. The incorporation process takes around 1-2 working day(s).

### 關於英屬處女群島

英屬處女群島的面積約為 150 平方公里，位於大西洋和加勒比海之間，距波多黎各東海岸約 60 公里，與美屬維爾群島毗鄰。主要島嶼為多都拉 (Tortola) 及由約 60 個小島組成。

英屬處女群島是一個自治管理的英屬殖民地，它已經發展成為海外商務活動的重要中心。

英屬處女群島一直享有相當穩定的政治及經濟環境。

### 成立英屬處女群島商業公司之方法

#### 1. 購買現成商業公司

此類公司由敝司先行辦理註冊登記手續，法定股數一般為 50,000 股，亦可以任何幣種出資。如有需要可向敝所索取現成商業公司名單，成立程序需時約 1-2 個工作天。

## Incorporation Methods of Business Company in BVI

### 2. Forming tailor-made Business Company

You can design your own company structure, e.g. numbers of authorised capital, company name, M&A specifications, etc., according to your specific needs. This method is more flexible but the incorporation process takes around 10 working days.

## Important Notice for Incorporation of Business Company in BVI

### 1. Number and Class of shares

50,000 shares of a single class of par value at USD1.00 each or no par value option.

### 2. Shareholder

- Minimum of 1 shareholder. Either natural person or legal entity can be a shareholder.
- Any nationality except BVI residents.
- Bearer shares are permitted but require custodial provision
- Disclosure the information of the Beneficial Owner to the Agent.

### 3. Director

- Minimum of 1 director. Either natural person or legal entity can be a director.
- Any nationality.

### 4. Company Secretary

- No requirement.

### 5. Registered Office

Local registered office in BVI is required.

### 6. Law and Taxation

- Common Law.
- No corporate taxation on offshore profit.

### 7. Official Chinese Name

Chinese name can be printed on the Memorandum and Articles of Association, and the Certificate of Incorporation.

## 成立英屬處女群島商業公司之方法

### 2. 自行成立商業公司

這種方法可按個人需要自定公司架構，如股本數目、公司名稱、章程細則等。此方法比第一種方法較有彈性，但成立程序需約 10 個工作天。

## 成立英屬處女群島商業公司應注意事項

### 1. 股數及類別

- 50,000 股單一類別股份，每股面值 1 美元或沒有面值的股份。

### 2. 股東

- 最少 1 位，個人或法人團體均可為股東。
- 無任何國籍限制，但英屬處女群島居民除外。
- 可發行不記名股票，但須遵守監管人相關條文
- 須向代理人披露最終受益人資料。

### 3. 董事

- 最少 1 位，個人或法人團體均可為董事。
- 無任何國籍限制。

### 4. 公司秘書

- 沒有規定。

### 5. 註冊地址

- 必須以英屬處女群島當地地址為註冊地址。

### 6. 法律及稅務

- 普通法。
- 不徵收離岸利得稅。

### 7. 中文名稱

- 公司章程及成立證書均可印上公司中文名稱。
