



## Brief Introduction of International Business Company in BAHAMAS 巴哈馬國際商業公司概述

### About Bahamas

Bahamas' total land area is around 13,900 sq. km. It is located in the North Atlantic Ocean, 78 km south east of the Miami, Florida and just north of Haiti, Cuba. It consists of nearly 700 islands and 2000 cays, with Nassau as its capital city.

Bahamas has been a British Crown Colony and became an independent country within the British Commonwealth in 1973, named as "Commonwealth of The Bahamas", or "The Bahamas" in short.

In 1997, Bahamas established a diplomatic relationship with China. It enjoys political stability since independence.

### Incorporation Methods of International Business Company in Bahamas

- Purchasing ready-made International Business Company**  
These companies will first be registered by IBC. The standard authorised capital is USD50,000 and can be in any currency. A list of ready-made International Business Companies will be provided upon request. The incorporation process takes around 7 working days.

### 關於巴哈馬

巴哈馬的面積約為 13,900 平方公里，位於大西洋西印度群島的最北部的巴哈馬群島上。美國佛羅裏達州邁阿密東南面對出海岸 78 公里、古巴海地北側。全境由 700 多個大小島嶼和 2,000 多個岩礁和珊瑚礁組成。首都設於拿薩（Nassau）。

曾為英國殖民地，於 1973 年英國政府批准了巴哈馬獨立法案後宣佈獨立，成為英聯邦成員國，國名為「巴哈馬國」，簡稱「巴哈馬」。

自 1997 年起與中國建交。自獨立至今，巴哈馬一直享有相當穩定的政治環境。

### 成立巴哈馬國際商業公司應注意事項

- 購買現成國際商業公司**  
此類公司由敝所先行辦理註冊登記手續，法定股本一般為 50,000 美元，亦可以任何幣種出資。如有需要可向敝所索取現成國際商業公司名單，成立程序需時約 7 個工作天。

## Incorporation Methods of International Business Company in Bahamas

### 2. Forming tailor-made International Business Company

You can design your own company structure, e.g., numbers of authorised, company name, M&A specifications, etc., according to your specific needs. This method is more flexible but the incorporation process takes around 2 weeks.

## Important Notice for Incorporation of International Business Company in Bahamas

### 1. Standard Authorised Capital

Standard of US\$50,000 divided into 50,000 shares of USD1.00 par value

### 2. Shareholder

- Minimum of 1 shareholder. Either natural person or legal entity can be a shareholder.
- Any nationality except Bahamas residents.
- No bearer shares are permitted.
- Disclosure the information of Beneficial Owner to Agent.

### 3. Director

- Minimum of 1 director. Either natural person or legal entity can be a director.
- Any nationality.
- Filing of Register of directors and officers at the Companies Registry on public record is required.

### 4. Registered Office

Local registered office is required.

### 5. Law and Taxation

- International Business Law
- No corporate taxation on offshore profit.

### 6. Official Chinese Name

No Chinese name can be printed on Certificate of Incorporation or Memorandum & Articles of Association.

## 成立巴哈馬國際商業公司之方法

### 2. 自行成立國際商業公司

這種方法可按個人需要自定公司架構，如股本數目、公司名稱、章程細則等。此方法比第一種方法較有彈性，但成立程序需時約 2 個星期。

## 成立巴哈馬國際商業公司應注意事項

### 1. 法定股本

一般股本為 50,000 美元，分為 50,000 股，每股面值 1 美元的股份為標準。

### 2. 股東

- 最少 1 位，個人或法人團體均可為股東。
- 無任何國籍限制，但巴哈馬居民除外。
- 不可發行不記名股票。
- 須向代理人披露最終受益人資料。

### 3. 董事

- 最少 1 位，個人或法人團體均可為董事。
- 無任何國籍限制。
- 必須把董事及高級職員名冊存於公司註冊處。

### 4. 註冊地址

必須以巴哈馬當地地址為註冊地址。

### 5. 法律及稅務

- 國際商業公司法。
- 不徵收離岸利得稅。

### 6. 中文名稱

- 公司註冊證書及公司章程均不可印上公司中文名稱。
