



Brief Introduction of International Business Company in BELIZE 貝里斯國際商業公司概述

About Belize

Belize's (formerly known as British Honduras) total land area is around 23,000 sq. km. It is located on the eastern or Caribbean coast of Central America, bounded on the north and part of the west by Mexico, and on the south and the remainder of the west by Guatemala. Its capital is located in Belmopan, but commercial activities mainly concentrated on Belize City.

Belize became a British Crown Colony in 1862 and declared independence in 1981. Belize recognises Her Majesty Queen Elizabeth II as Head of State, but the government is led by its Prime Minister.

Belize is peaceful country and enjoys political stability.

Incorporation Methods of International Business Company in Belize

1. Purchasing ready-made International Business Company

These companies will first be registered by IBC. The standard authorised capital is USD50,000, which can be in any currency. A list of ready-made International Business Companies will be provided upon request. The incorporation process takes around 2 working days.

關於貝里斯

貝里斯（又名伯利茲）的面積約為 23,000 平方公里，位於中美洲加勒比海東岸。北鄰墨西哥，西南方與厄地馬拉接壤。首都設於貝爾墨潘市（Belmopan），惟商業活動主要集中在貝里斯市（Belize City）。

於 1862 年成為英國殖民地，而在 1981 年開始實行自治。政治上，是經貝里斯總督代表英女皇依利沙伯二世及英國來統治，政務實際由總理執行。

貝里斯是一個和平的國家，一直享有相當穩定的政治環境。

成立貝里斯國際商業公司之方法

1. 購買現成國際商業公司

此類公司由敝所先行辦理註冊登記手續，法定股本一般為 50,000 美元，亦可以任何幣種出資。如有需要可向敝所索取現成國際商業公司名單，成立程序需時約 2 個工作天。

Incorporation Methods of International Business Company in Belize

2. Forming tailor-made International Business Company

You can design your own company structure, e.g., numbers of authorised capital, company name, M&A specifications, etc., according to your specific needs. This method is more flexible but the incorporation process takes around 2 weeks.

Important Notice for Incorporation of International Business Company in Belize

1. Standard Authorised Capital

Standard of US\$50,000 divided into 50,000 shares of USD1.00 par value

2. Shareholder

- Minimum of 1 shareholder. Either natural person or legal entity can be a shareholder.
- Any nationality except Belizean residents.
- Bearer shares are permitted without additional annual government fee.

3. Director

- Minimum of 1 director. Either natural person or legal entity can be a director.
- Any nationality.

4. Company Secretary

- No requirement.

5. Registered Office

Local registered office is required.

6. Law and Taxation

- Common Law.
- No corporate taxation on offshore profit.

7. Official Chinese Name

Chinese name can be printed on both Certificate of Incorporation and Memorandum & Articles of Association and possesses legal standing.

成立貝里斯國際商業公司之方法

2. 自行成立國際商業公司

這種方法可按個人需要自定公司架構，如股本數目、公司名稱、章程細則等。此方法比第一種方法較有彈性，但成立程序需時約 2 個星期。

成立貝里斯國際商業公司應注意事項

1. 法定股本

一般股本為 50,000 美元，分為 50,000 股，每股面值 1 美元的股份為標準。

2. 股東

- 最少 1 位，個人或法人團體均可為股東。
- 無任何國籍限制，但貝里斯居民除外。
- 可發行不記名股票，而不需加收政府年費。

3. 董事

- 最少 1 位，個人或法人團體均可為董事。
- 無任何國籍限制。

4. 公司秘書

- 沒有規定。

5. 註冊地址

必須以貝里斯當地地址為註冊地址。

6. 法律及稅務

- 普通法。
- 不徵收離岸利得稅。

7. 中文名稱

公司註冊證書及公司章程均可印上公司中文名稱，且具法律效力。
