



Brief Introduction of International Company in SAMOA 薩摩亞國際公司概述

About Samoa

Samoa's total land area is around 2,800 sq. km. It is located in the centre of the Southern Pacific Ocean, and west of the Samoa Islands. With Apia as its capital city, Samoa consists of two large islands, Savaii and Upolu, and 7 small islands.

Samoa has been administered by Britain, Germany and New Zealand in various periods. It declared independence in 1962 and named as "Western Samoa". In 1997, it changed its name to "Independence State of Samoa" or "Samoa" in short.

In 1975, Samoa established a diplomatic relationship with China. It enjoys political stability since independence.

Incorporation Methods of International Company in Samoa

- Purchasing ready-made International Company**
These companies will first be registered by IBC. The standard authorised capital is USD1,000,000, which can be in any currency. A list of ready-made International Companies will be provided upon request. The incorporation process takes around 3 working days.

關於薩摩亞

薩摩亞的面積約為 2,800 平方公里，位於太平洋南部，薩摩亞群島西部。首都設於阿皮亞（Apia），全境由薩瓦伊島（Savaii）和烏波盧（Upolu）兩個主島及 7 個小島組成。

先後曾為英國、德國及新西蘭的屬地，於 1962 年透過獨立憲法宣佈獨立，國名為「西薩摩亞」。在 1997 年正式改稱為「薩摩亞獨立國」，簡稱「薩摩亞」。

自 1975 年起與中國建交。自獨立至今，薩摩亞一直享有相當穩定的政治環境。

成立薩摩亞國際公司之方法

- 購買現成國際公司**
此類公司由敝司先行辦理註冊登記手續，法定股本一般為 1,000,000 美元，亦可以任何幣種出資。如有需要可向敝所索取現成國際商業公司名單以供選擇，程序需時約 3 個工作天。

Incorporation Methods of International Company in Samoa

2. Forming tailor-made International Company

You can design your own company structure, e.g., numbers of authorised capital, company name, M&A specifications, etc., according to your specific needs. This method is more flexible but the incorporation process takes around 3 weeks.

Important Notice for Incorporation of International Company in Samoa

1. Standard Authorised Capital

Standard of US\$1,000,000 divided into 1,000,000 shares of USD1.00 par value

2. Shareholder

- Minimum of 1 shareholder. Either natural person or legal entity can be a shareholder
- Any nationality except Samoa residents.
- Bearer shares are permitted.

3. Director

- Minimum of 1 director. Either natural person or legal entity can be a director.
- Any nationality.

4. Company Secretary

- Minimum of 1 company secretary. Either natural person or legal entity can be a company secretary.
- Any nationality.

5. Registered Office

Local registered office is required.

6. Law and Taxation

- Base on English Common Law.
- No corporate taxation on offshore profit.

7. Official Chinese Name

Chinese name can be printed on both Certificate of Incorporation and Memorandum & Articles of Association and possesses legal standing.

成立薩摩亞國際公司之方法

2. 自行成立國際公司

這種方法可按個人需要自定公司架構，如股本數目、公司名稱、章程細則等。此方法比第一種方法較有彈性，但程序須時約 3 個星期。

成立薩摩亞國際公司應注意事項

1. 法定股本

一般股本為 1,000,000 美元，分為 1,000,000 股每股面值 1 美元的股份為標準。

2. 股東

- 最少 1 位，個人或法人團體均可為股東
- 無任何國籍限制，薩摩亞居民除外
- 可發行不記名股票。

3. 董事

- 最少 1 位，個人或法人團體均可為董事
- 無任何國籍限制

4. 公司秘書

- 最少 1 位，個人或法人團體均可為公司秘書
- 無任何國籍限制

5. 註冊地址

必須以薩摩亞當地地址為註冊地址

6. 法律及稅務

- 英式司法體系。
- 不徵收離岸利得稅

7. 中文名稱

公司註冊證書及公司章程均可印上公司中文名稱，且具法律效力
