



Brief Introduction of International Business Company in SEYCHELLES 塞舌爾國際商業公司概述

About Seychelles

Republic of Seychelles' (also known as Seychelles) total land area is around 454 sq. km. It is located in the north of Madagascar, Kenya, and 1,000 km. of western Indian Ocean. With Victoria as capital and it consists of 100 small islands

Seychelles is former colony of France and United Kingdom in various periods. It declared its independence and established a diplomatic relationship with China since 1976. Seychelles has been enjoying political stability since its independence.

Incorporation Methods of International Business Company in Seychelles

1. Purchasing ready-made IBC

These companies will first be registered by IBC CORPORATE SERVICES LIMITED. The standard authorised capital is USD100,000, which can be in any currency. A list of ready-made International Business Companies will be provided upon request. The incorporation process takes around 7 working days.

關於塞舌爾

塞舌爾共和國(簡稱「塞舌爾」)的面積約為 454 平方公里，散佈在東南非洲馬達加斯加島北方約 1,000 多公里處的西印度洋上。首都設於維多利亞 (Victoria)，全境由 100 多個小島組成。

先後曾為法國、英國的屬地，於 1976 年正式宣佈獨立。自 1976 年起與中國建交。自獨立至今，塞舌爾一直享有相當穩定的政治環境。

成立塞舌爾國際商業公司之方法

1. 購買現成國際商業公司

此類公司由敝所先行辦理註冊登記手續，法定股本一般為 100,000 美元，亦可以任何幣種出資。如有需要可向敝所索取現成國際商業公司名單以供選擇，程序需時約 7 個工作天。

Incorporation Methods of International Business Company in Seychelles

2. Forming tailor-made International Business Company

You can design your own company structure, e.g., numbers of authorised capital, company name, M&A specifications, etc., according to your specific needs. This method is more flexible but the incorporation process takes around 2-3 weeks.

Important Notice for Incorporation of International Business Company in Seychelles

1. Standard Authorised Capital

Standard of US\$100,000 divided into 100,000 shares of USD1.00 par value

2. Shareholder

- Minimum of 1 shareholder. Either individual person or legal entity can be a shareholder.
- No requirement of nationality except Seychelles residents.
- Bearer shares are permitted.

3. Director

- Minimum of 1 director. Either individual person or legal entity can be a director.
- No requirement of nationality.

4. Company Secretary

- No requirement.

5. Registered Office

Local registered office address is required.

6. Law and Taxation

- Base on English Common Law.
- No corporate taxation on offshore profit.

7. Official Chinese Name

Chinese name can be printed on Certificate of Incorporation and Memorandum & Articles of Association and possesses legal power.

成立塞舌爾國際商業公司之方法

2. 自行成立國際商業公司

這種方法可按個人需要自定公司架構，如股本數目、公司名稱、章程細則等。此方法比第一種方法較有彈性，但程序須時約 2-3 個星期。

成立塞舌爾國際商業公司應注意事項

1. 法定股本

一般股本為 100,000 美元，分為 100,000 股，每股面值 1 美元的股份為標準。

2. 股東

- 最少 1 位，個人或法人團體均可為股東。
- 無任何國籍限制。
- 可發行不記名股票。

3. 董事

- 最少 1 位，個人或法人團體均可為董事。
- 無任何國籍限制。

4. 公司秘書

- 無任何限制。

5. 註冊地址

- 必須以塞舌爾當地地址為註冊地址。

6. 法律及稅務

- 英式司法體系。
- 不徵收離岸利得稅。

7. 中文名稱

- 公司註冊證書及公司章程均可印上公司中文名稱，並且具法律效力。
